16.2 University governance measures

16.2.1 Elected representation

The University of Tabuk has established a comprehensive system of councils and committees that function as key mechanisms for participatory governance, ensuring inclusive representation of faculty, staff, and students. Among the most prominent are the University Council, which provides strategic direction and sets institutional policies; the Faculty and Department Councils, which oversee academic planning and operational matters within their respective units; and the Student Council, which serves as a platform for student engagement, advocacy, and participation in decision-making processes. Furthermore, advisory committees at both the college and departmental levels play a critical role in offering expert guidance, supporting effective governance, and promoting collaboration across the university.

University Council:



University Council: The University Council plays a central role in the governance of the University of Tabuk. It oversees the strategic direction, policies, and key decisions affecting academic and administrative affairs. All details regarding the Council, including its composition, responsibilities, duties, and regular meetings, are provided [the University of Tabuk Procedural Guide](#) (pp. 24–34).

Faculty Councils: These councils are responsible for managing the affairs of their respective faculties within the scope defined by the Higher Education Council and Universities Regulations. Detailed information is provided in [the University of Tabuk Procedural Guide](#) (pp. 39–44).

Department Councils: The council is responsible for managing the academic, financial, and administrative affairs of the department within the limits stipulated by the Higher Education Council and Universities Regulations. Student Council

The Student Council at the University is formed as follows:

- Chair: President of the University of Tabuk
- Vice-Chair: Vice President for Educational Affairs
- Secretary: Dean of Student Affairs

Members:

- One student representative from each college and branch campuses
- One student with disabilities
- One scholarship student
- One postgraduate student
- Council Rapporteur: An administrative staff member

Objectives of the Council:

- Understand the needs and aspirations of university students regarding university management.
- Open channels of communication and dialogue between students and the university administration, and strengthen the relationship between students and university officials.
- Foster a sense of belonging among university students.
- Train students in leadership skills and provide them with opportunities to express their opinions.
- Identify and develop students' talents and capabilities, utilize student energies in ways that benefit the university and society, and promote a spirit of participation.
- Enhance student involvement in decision-making processes that affect their affairs and provide the university with insights into their perspectives.

16.2.5 University principles on corruption and bribery

University Principles on Corruption and Bribery

The University of Tabuk is committed to promoting integrity, transparency, and ethical conduct across all academic and administrative practices. Through the **Intellectual Awareness Unit**, the university actively raises awareness of the dangers of organized crime, corruption, bribery, and other unethical practices, while fostering a culture of responsibility, national loyalty, and peaceful coexistence.

Established by Royal Decree No. (35391) dated 19/1/1435 AH and supported by Royal Decree No. (27526) dated 21/6/1436 AH, the Intellectual Awareness Unit operates under the direct supervision of the University President as an independent department dedicated to intellectual and ethical development. Its mission is to prevent and address intellectual and behavioral deviations by implementing strategic initiatives, educational programs, and awareness campaigns for students, faculty, and the wider community.

Key commitments include:

- Publishing principles of ethical conduct and zero tolerance for corruption, bribery, and organized crime.

- Promoting a culture of transparency, accountability, and lawful practices within the university.
- Implementing preventive and corrective measures to address intellectual and behavioral risks.
- Organizing training, workshops, and campaigns to raise awareness of anti-corruption measures.
- Strengthening community engagement to reinforce national identity, ethical responsibility, and moderate values.



16.2.7 Publish financial data

16.3.1 Provide expert advice to the government.

The University of Tabuk, through its Research and Consulting Institute, actively provides expert advice and consultancy services to local, regional, and national government bodies, as well as private sector organizations. The institute serves as the university’s contractual interface and business hub, coordinating scientific, research, and advisory services across all university units and facilities. It is recognized for its high professional standards, scholarly rigor, and strategic contributions to development initiatives.

Key activities and examples include:

- Conducting feasibility studies for technical projects in collaboration with the Tabuk Emirate, providing actionable insights to support regional development.
- Completing social and cultural surveys for projects in the Red Sea region, Amala, and surrounding areas, delivering data-driven recommendations to inform policy and planning.
- Providing faculty members with guidance and tools, such as the Guide for Preparing Technical and Financial Proposals, to support their consultancy work with external stakeholders.

16.3.2 Policy- and lawmakers outreach and education


